**JURISDICTION.** The event will be held under the International Sporting Code of the F.I.A., the National Competition Rules of the Confederation of Australian Motorsport Ltd. (CAMS Ltd), the CAMS passenger in Vehicle Guidelines and these Supplementary Regulations. Additional Instructions may be issued subject to NCR 69.

Insurance for this event will be provided in accordance with Appendix I of the current CAMS Manual.

**THE COURSE** will be the Mt. Cotton Hill Climb Course, 37 kilometres from Brisbane, Gramzow Road off Ring Route 45. The course is 946 metres long and bitumen sealed.

(a) Entries will be open on publication of these Supplementary Regulations.

(b) Entry fee for Driver Training will be \$150.00 and Test and Tune \$50.00 per driver

(c) Personal Accident Insurance is included in the fee.

Persons eligible to compete are the participants and drivers who are current members of a CAMS affiliated club and must possess a current Level 2S licence or higher unless first time Come and Try drivers and may use a Level 2 day licence

#### 4. STARTING TIME.- PROGRAMME OF EVENTS.

Drivers briefing will be held at 8.00 am on Sunday 21<sup>st</sup> February 2010 near the Scrutiny Shed and any subsequent times as advised by the Clerk of Course.

7.00am Arrival  
7.00 – 7.55am Administration Paperwork check and Scrutiny check  
8.00am Driver's Briefing and Introduction  
8.15am Split into groups and walk the track  
9.00am Slow runs with Mt Cotton Experience Trainer in passenger seat – Helmets & safety gear  
10.30am Commencement of slow solo untimed runs  
12.00 noon Commencement of 8/10<sup>th</sup>'s timed runs  
12.45pm Completion of Driver Trainer  
1.00pm Test and Tune timed runs  
4.00pm approximately Finish of Test and Tune

Test & Tune runs will commence at 1.00 pm on Sunday 21<sup>st</sup> February 2010.

**5. SCRUTINY TIME AND PLACE** (a) Safety checks vehicles will take place at the course between 7.30 am. & 2.30 pm. on Saturday of the event. Those vehicles presented in unsuitable condition may be excluded by the Clerk of Course and Chief Scrutineer.

**8. ABANDONMENT OR POSTPONEMENT:** The organisers reserve the right at their sole discretion to abandon, postpone or cancel the event subject to NCR 59.

**10. ENTRY PROCEDURE:** (a) Entries will not be accepted unless the entry form is complete in all details and accompanied by the specified entry fee.

(c) The organisers reserve the right to refuse entries subject to NCR 83.

(d) **Multiple entries of vehicles will be permitted with different drivers for each entry.** A separate entry fee is to accompany each entry and this entitles the vehicle to a start for each participant. Relief Drivers are not permitted for this Test and Tune Day.

**11. THE EVENT** (a) **Driver training** will include both beginners and those competent competitors seeking to improve their performance by further intensive training and direction followed by personal Test & Tune. Any passengers in vehicles must sign the passenger in vehicle disclaimer form, and must adhere to the CAMS passenger in vehicles guidelines.

**Test and Tune participants** will circulate the Hillclimb to enable the driver to increase both their own and the vehicle's performance. If approved by organizing committee and Chief Steward, these competitors may receive additional in car training by approved experience trainers.

(b) The test & tune afternoon will attempt to post run times, but this may not necessarily happen as this is also a timekeepers training day.

(c) Vehicles will be allocated trainers by the organizers. Each trainer will look after a limited number of competitors. Numbers per trainer will be related to the experience of the competitor.

(c) If a vehicle due to mechanical failure or for other reasons fails to reach the finish line, it shall be removed immediately from the course and will be deemed to have finished that run.

(d) One burn out only (before the start line) will be allowed at each start.

#### 12. SCRUTINY PROCEDURE:

(a) **Paperwork is to be checked and verified before vehicles are allowed to enter the scrutiny area.**

**Documents: The following documents must be presented at administration office for scrutiny form.**

Current CAMS Competition Licence/ CAMS Pass Book - - Level 2S or higher

Current CAMS Affiliated Car Club Membership

CAMS Vehicle Log Book - must be presented for all vehicles which have been issued with one.

Possession of this document for vehicles is not compulsory.

CAMS Certificate of Description (5th Category only) - other than Group N & S.

**Vehicles having current registration in Queensland under the "Transport Operations (Road Use Management - Vehicle Registration) Regulation 1999" require a Compulsory Third Party Extension Insurance (CPT1) valid for this event for test and tune entrants.**

No Vehicle will be permitted to enter the track unless it has been approved by the Scrutineers safety check.

***Come and Try competitors wishing to continue on to Test and Tune must revisit Scrutiners for recheck.***

(b) **The following must be presented at scrutiny for**

Helmet, clothing (goggles and gloves if required), valid current dated fire extinguisher

CAMS Vehicle Log Book - must be presented for all vehicles which have been issued with one.

Possession of this document for vehicles is not compulsory.

CAMS Certificate of Description (5th Category only) - other than Group N & S.

**Vehicles having current registration in Queensland under the "Transport Operations (Road Use Management - Vehicle Registration) Regulation 1999" require a Compulsory Third Party Extension Insurance (CPT1) valid for this event for test and tune entrants.**

c) Crash Helmets, goggles or visors, fire extinguishers and seat belts must be CAMS approved types. See Appendix C points 4, 8, 9. *Fire extinguishers must be fitted except for specific new Come and Try competitors training. All Test and Tune competitors must have a fire extinguisher.*

- (d) All trainers must complete a passenger in vehicle disclaimer form before proceeding onto the track.
- 13. SAFETY EQUIPMENT:** Whilst it is preferred that CAMS approved fire-retardant clothing be worn, this is not mandatory. The minimum standard of dress required for all participants will consist of long trousers, long sleeved woollen shirt or jumper, with shoes and socks. (Thongs and sandals are not acceptable). Clothing and footwear of synthetic material such as nylon, is not acceptable.
- 14. VEHICLES:** (a) All headlights must be adequately masked.  
(b) Participants permanent racing numbers will be used where possible.  
(c) **This number shall be displayed on both sides of the vehicle**  
(d) The organisers reserve the right to reject any vehicle not presented in a clean and tidy condition.  
(e) **ALL VEHICLES MUST BE FITTED WITH AN EFFICIENT MUFFLER TO LIMIT NOISE TO 95dB.**  
Non-complying vehicles may be excluded from the event.

**15. GENERAL:**

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s).

**Other Prohibited Substances**

The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such.

In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.

(c) It is a condition of entry that participants agree to pay all costs incurred by the MG Car Club of Qld. Inc. for the use of fire fighting equipment on any vehicles used by the participant/drivers./pit
